The Royal Academy of Arts celebrates the career of French architect Renée Gailhoustet with 2022 RA Architecture Prize

Nominees announced for £10,000 Royal Academy Dorfman Award

31 May 2022 **LONDON, UK**

- 2022 Royal Academy Architecture Prize awarded in recognition of Renée Gailhoustet's pioneering work as an architect designing public housing and neighbourhoods in and around Paris during a forty-year career that began in 1961.
- Four architects have been nominated for the £10,000 2022 Royal Academy
 Dorfman Award, which celebrates new ideas and practices that highlight the
 future potential of architecture. The nominated practices are Apparata (UK),
 dot architects (Japan), Semillas (Peru), and Wallmakers (India).
- The 2022 Royal Academy Architecture Prize and the 2022 Royal Academy
 Dorfman Award will be presented at a ceremony during Royal Academy
 Architecture Awards Week, 12 16 September 2022, a public celebration of
 architecture at the Royal Academy in London.
- The Royal Academy Architecture Prize is awarded to an individual or practice whose idea or body of work has made a positive contribution to the public and had a significant impact on society. The Royal Academy Dorfman Award was established to encourage and celebrate architects around the world whose work explores new ideas and ways of practising architecture. The Awards are generously supported by The Dorfman Foundation.

The Royal Academy has announced that the 2022 Royal Academy Architecture Prize will be awarded to **Renée Gailhoustet** to honour her extraordinary contribution to social housing in France and her inspirational approach to building communities and urban planning.

Farshid Moussavi RA, Chair of the 2022 Royal Academy Architecture Awards Jury, said:

"Renée Gailhoustet's achievements reach far beyond what is produced as social or affordable housing anywhere today. Her work has a strong social commitment that brings together generosity, beauty, ecology, and inclusivity.

"This award highlights housing design as one of the most pressing and complex issues of our time by inviting the public to rediscover the work of one of the most committed and prolific practitioners of the 20th Century – an architect who pioneered a new approach to housing design, and was an early adopter of important principles such as generous public space and nature in the city."

Born in Oran in French Algeria in 1929, Renée Gailhoustet enrolled in the École Nationale des Beaux-Arts de Paris, gaining her diploma in 1961. Gailhoustet founded her own firm by 1964 and went on to produce a succession of visionary public housing projects that includes such projects as La Maladrerie in Aubervilliers and Le Liégat in Ivry-sur-Seine, where she designed the master plan of the city centre and invited Jean Renaudie to develop the first built expression of his Étoiles apartment buildings.

The Royal Academy jury's statement highlights Renée Gailhoustet's "extraordinary contribution to social housing in France", citing her impressive body of work that "consistently reflects her interest in realising architecture as a social and cultural practice."

The statement goes on to say that "Gailhoustet's buildings demonstrate a belief in social connections and an aspiration for structures and urban environments that are cohesive but underpinned by diversity. They integrate dwelling and nature at the heart of the city and champion collaboration in the design and urban development process."

The Royal Academy has also announced four architecture practices nominated for the **Royal Academy Dorfman Award**. The Dorfman Award champions architecture from around the world that looks forward to the future of architecture and architectural practice. The winner will receive £10,000 prize money to support the development of their practice. The 2022 nominees are:

The Royal Academy Dorfman Award nominees will convene in London during **Royal Academy Architecture Awards Week, 12 – 16 September 2022,** a public celebration of architecture at the Royal Academy in London. Following a week of public events and private jury sessions, the winner will be announced at a prize-giving ceremony that will also mark the official investiture of Renée Gailhoustet as a Royal Academy Architecture Prize-winner.

- RA Architecture Awards Ceremony on Thursday 15 September, 6.30 8pm

As ever, we are inspired by the brilliance of the architects chosen by the RA for our Awards, which continue to spotlight talent all over the world."
